THONW Inc Chair Report for April 2023 Rūnanga Meeting

Lyttelton West School Site Project

We continue to make good progress with the purchase of the site complete and we are working closely with Te Rūnanga o Ngāi Tahu and Kāinga Ora. We are also looking to have a whānau hui in May to consider options for use of the site.

Appointment of Project Manager

Following an expression of interest process we have appointed local firm Verve as project manager for the Rāpaki School restoration project and for the redevelopment of 18a. We will arrange a meet and greet opportunity for whānau in late April/early May.

Rāpaki School

With the design previously finalised and signed off by the Rūnanga and Reserve Trustees, resource consent obtained and building consent almost completed, we will be working with Verve to undertake an EOI/RFP (request for proposals) for builders/construction firm to undertake the move and restoration/upgrade. This will not be an easy project as there are challenges particularly given the age of the school, so we will move carefully to ensure the unique character of the school is protected and enhanced and that we end up with a facility we can use for a wide purposes long into the future.





18a Redevelopment

18a requires more planning work to take account of the growing need for Office and meeting space before any design decisions can be finalised. We will work with Verve to recommence this process and keep whānau up to date with progress.

ANZAC Commemoration 2023

2023 will see the usual ANZAC service and breakfast on Tuesday 25th April. There is also a service in Lyttelton that will follow on later in the morning.

Coastal Hazards Project

Final feedback from us is due to go to CCC by 10 May. We are aiming for a workshop for whānau in late April/early May to review options and confirm our views. Details to follow.

Te Pātaka o Rakaihautu Whānau Ora Hub proposal

Our Whānau Ora team are working well but as we all know this can be challenging mahi and kaimahi working in the space need to be well supported. We have therefore agreed to work with other local Rūnanga to scope the practicalities and benefits of a jointapproach to Whānau Ora. This outcome could be navigators employed by a new joint entity or it might just see them working more collaboratively possibly based at a shared hub. This scoping exercise will be undertaken by Kylie Jane Phillips, will take place over the next few months and will include kōrero with whānau.

Staffing Updates

- Michael Parata leaving us to go back to full-time building. With the māra kai funding agreement with Te Putahitanga coming to an end we will need to reassess how we continue to support whānau and communal māra
- Lani Tukariri has gone to a new full time role at Canterbury Univeristy library but will continue to work for us on a casual basis particularly around whānau events such as tamariki day
- Waiariki Paraone left us last month to become a catering sole trader. While we undertake
 the staffing and structure review we are making use of contract caterers for most manuhiri
 and we also have 2-3 new casuals to do cleaning and kai prep for powhiri.
- Materia Hutana will remain with us through til February 2024 when she returns to study to Te Wānanga o Raukawa working primarily with Lynette Cotterill on education related mahi along with projects such as the papatākaro.

Review of Strategic Plan and Development of Evaluation Framework

As previously noted we will hold wananga to review the strategic plan later this year to ensure it remains relevant and supports our aims and visions. In preparation for that we are working with lhi Research Limited to develop an evaluation framework to provide a clear and simple way to measure progress toward the strategic plan goals and to make clear how the different projects intersect and contribute.

Website

We now need whānau feedback as we work to continue to develop the website and add more content that whānau would like. The public section is open to all at www.rapaki.iwi.nz. To obtain a login to the whānau section please email rapaki@ngaitahu.iwi.nz.

Emergency Management Plan Whānau Engagement Session

We recently had CCC staff visit to provide guidance around development of an Emergency Management Plan and we now need whānau input to develop a comprehensive plan for the marae and local residents. Anyone interested in participating in a whānau session to help develop this, should contact the Office.

Waitaha Priorities Group Membership

In response to COVID -19 the government established Regional Leadership Groups ('the RLG') which worked towards a joined up government and community approach to address the issues and challenges that arose because of COVID-19. Following removal of the COVID Protection Framework, the RLG was disbanded in October 2022. A successor group known as the 'Waitaha Priorities Group' (WPG), has been established to help support a more unified approach to addressing some of these needs. We now have an opportunity to put someone on the WPG. Anyone interested in taking up this role on behalf of the Rūnanga should provide their details to the Office.

SailGP

Our big thanks to everyone who contributed to SailGP. It was a huge amount of work from so many people but the end result was very positive both with the pōwhiri held at the marae, and the hapū and iwi presence at the event and on the water. Our ties with local communities were strengthened with many coming to volunteer and it was a great opportunity for many whānau to get out on our waka. We also had environmental projects that benefitted from funding and profile raising. We will debrief fully in due course.

General Election Booth at Rāpaki

In 2020 we had a public electoral booth at the marae. The Electoral commission has asked whether we would like to repeat it. It would be on Sunday 8 October when rūnanga meeting is on as well as a proposed sports day for tamariki. Location would either be the marae dining room or gallery or at 18A.

Te Runanga o Ngai Tahu Representative Report

APRIL 2023

Firstly, I would like to acknowledge the huge amount of mahi and time that both Rapaki and Horomaka whanau committed to the SailGP event which took place in March, both the Powhiri and the race days were a huge success. There was significant attention focussed on our cultural practices, environmental challenges and programs and focus on aspirations in these areas, to be addressed in the future. Well done to all involved.

The TRONT hui, held in March covered a number of issues which I have reported on below:

Relativity Allocation: The total amount of relativity received by Tront this year is \$96.5Million, this will be distributed between Papatipu Runanga, NT Regional Investment Fund and Whai Rawa, the exact split will be confirmed in the next few weeks. In the past this relativity money has been allocated directly to NT Holdings, however, the decision was made not to allocate to NT Holdings and instead to support PR this year. This funding is intended to provide putea to assist cultural and people growth, and support Rangatiratanga, sitting alongside the NT Regional Investment Fund which supports PR in commercial activities.

The rational for this is based on providing PR with appropriate resources to assist capacity and capability building, so that they can address their needs, as they see fit. This means that PR will have significant funds they can draw on to create and implement programs and engage the right people, to grow, document and share:

- Cultural knowledge, Matauranga, Toi (the arts), Kapahaka, Te Reo, Mahinga Kai and other
 Cultural Practices, to support and grow Engagement and Capacity at Marae.
- Ensuring training and sharing of knowledge and building capacity in the Natural Resources /
 Environmental areas to ensure protection of our rights and interests for the Taiao and other
 mahi important to PR and hapu.
- NT Boundary Protection: The Takiwa Advisory Group including members David Higgins, Ta Tipene, Francois Tumahai, Maurice Manawatu and Te Maire Tau, have been working in the area of protecting our takiwa boundaries for many years, with increasing challenging to our upper boundary from other lwi and pan Maori groups, it was agreed to provide this group with admin and budget support to continue and capture their mahi. This mahi has become more complex and high stakes in areas such as the NT boundary on the west coast and Kaikoura and includes mahi such as Molesworth Station and other claims, and also has impacts on central govt boundaries for Health Reforms, 3 Waters etc.

April TRoNT hui includes general agenda matters covering Alternate Representative Fees, this will provide a fairer payment schedule for Alternates, a question was raised regarding the pathway for Alternates to move into Representative roles was discussed and this will be addressed in future Form and Function work planned for later in the year. Another important piece of work is around the new RMA legislation and how we will need to work with Government under the new laws, Stategy and Influence have produced a document which sets out what process needs to happen to ensure that we are able to continue to protect our rights and interests as mana whenua in the RMA workspace.

FINANCE REPORT

For the nine months ended 31 March 2023

For the financial year ending 30 June 2023

INTRODUCTION

Please refer to the financial summaries included in this report for the nine months ended 31 March 2023 that summarises the operating income and expenses, a detailed set of financial reports are available on request.

All supplier bills received have been recorded. Although, there may be several supplier bills and invoices still to be recorded, the report gives a good indication of the financial performance.

OPERATING INCOME

Funding is available from Te Poho o Tamatea Ltd (TPoT) to support the day-to-day operating expenses. The Service Level agreement (SLA) provides funding up to \$612,000 for the year ending 30 June 2023. This funding is the biggest source of income and can be drawn down in monthly instalments. As of 31 March 2023, TPoT has been invoiced \$459,000 (\$51,000 x 9 months) of which \$357,000 (7 months) has been paid to date, with the remaining \$102,000 scheduled for payment in April.

Any income received in advance, for example, deposits paid for marae hire have been journaled to income received in advance.

Marae income and expenses are consistent with the previous three months of trading, in that it is typically running at a loss.

All other income is in line with prior months; except for:

- Rata Foundation operating grant for \$40,000
- Refund received for Charitable Grant of \$4,000

OPERATING EXPENSES

All other expenses are in line with prior months, except for:

- ACC Expenses for \$2,280
- Promotional Merchandising for \$6,409
- Health & Safety (First Aid kits, defibrillator batteries & pads) for \$1,011
- Professional Services for \$3,600

FINANCIAL POSITION

Funds held in the bank as of 31 March 2023 were \$314,731 (Feb 2023: \$765,370). These funds include externally funded project monies received to date. Most assets are land and buildings.

The accounts receivable balance of \$82,715 is mainly made up of outstanding invoices between current and 30 days outstanding. Accounts receivable is frequently monitored and followed up internally by the office.

Chairs Report

Lyttelton West - Mishele overviewed her report. Discussion regarding separation between TPOT and THONW Inc. If it is straight commercial it would be TPOT Ltd but because it has mixed purpose it may remain with the Rūnanga. Should TPOT Ltd be contracting the project work? Will be resolved as we work through the project.

Hastings Piupiu – pōwhiri set down for 12.30.

Reserves Committee Position Statement – noted need to be clear about who the reps are, and what the overall position of the Rūnanga is. Flo McGregor's thanked the Rūnanga (via email) for the opportunity to remain on the Lyttelton Reserve Committee.

Noted James Korako actual name; Hemi can be used in brackets.

Action: Office to confirm who allows what to happen on Reserves and when. Pipe bands and weddings etc.

Whakaraupō Recreation Inc

Hub location – Craig Pauling gave an overview of the building design/location options noting the preference for option 1 given its proximity to the water and for the integration of the wharewaka as part of the hub building. This preference was supported by the meeting.

Representative appointment Flo McGregor, Craig Pauling and Justin Walsh all put their names forward for the two representative positions.

- Flo has advised she has agreed to withdraw her nomination to allow Craig and Justin to take up the roles. Flo also thanked the Rūnanga for the opportunity to seek the role.
- Craig and Justin confirmed as the representatives.
