## 3. Rāpaki Reserve Trustees Annual Report for the year ending 30 June 2022

Pat Hutana served as a Rāpaki Reserve Trustee for six years and served as Chair for 4 of those years. We mihi to Pat's whānau and acknowledge the contributions he made during his time as a trustee. We also acknowledge all others who passed during the past year.

Pat Hutana and Matea Gillies offered this year to end their term as trustee to implement a staggered rotation of Trustees enable new trustees to step forward. The trustees also offer their thanks to Matea for his significant contribution over the past six years.

The current Trustees are: Reihana Parata, Matea Gillies, Makere Fahey-Herewini, Luana Swindells, Catherine Stuart, and Mishele Radford.

The Rāpaki Reserve Trustees are responsible for 10 properties as shown at the end of this report.

The nomination process for new trustees to replace Pat Hutana and Matea Gillies saw Nik Randle and Kahu Piripi nominated to fill the two vacancies. Their applications have been lodged with Te Kooti Whenua Māori and the trustee transition process should be completed late 2022.

The work of the trustees revolves around the properties named above and focuses on ensuring they are used appropriately, properly maintained, and where applicable, are redeveloped or enhanced.

In relation to improvement/development of facilities, proposals are generally developed in consultation with the Rūnanga. Key projects considered during the year included the following:

- Marae improvements: dining room extension and other improvements including sound insulation, sound system, kitchen venting improvements and laundry all but completed.
- School restoration/upgrade: the trustees worked carefully through the proposed restoration and upgrade of the school and look forward to seeing this implemented next year, funding permitting.
- Playground redevelopment: the trustees have provided input into the proposed playground redesign and look forward to seeing the new proposed design very soon.

During the year the Trustees commenced a review of current legal rules that guide them to ensure those rules are fit for purpose. Once any recommendations are prepared these will come to whanau for input.

The Trustees also undertook trustee training during the year led by Mike Quinn which was very useful in helping to clarify the roles and responsibilities of trustees.

The Trustees note the current issues around the legal ownership of Rāpaki 875 Reserve Sections 19 and 20 and that applications in relation to ownership of both sections have been lodged with Te Kooti Whenua Māori.

Thanks to all the whanau who have contributed to and guided and supported all these important kaupapa.
